#### HIGHLIGHTS FROM THE AAP TASK FORCE ON IMPROVING THE EFFECTIVENESS OF HEARING SCREENING, **DIAGNOSIS, AND INTERVENTION MEETING**


The AAP Task Force on Improving the Effectiveness of Hearing Screening, Diagnosis, and Intervention convened on November 14-15 for their annual in-person meeting. Highlights from the 11/2 day meeting are noted below:

- There are three new task force members, Drs Martin Beals (AK), Brad Golner (AZ), and Debra Waldron (IA)
- Dr Charles Bower, liaison from the AAP Section on Otolaryngology, Head and Neck Surgery has joined the Task Force
- The primary focus of the meeting was strategic planning for the future of the EHDI program
- A portion of the meeting was dedicated to looking at the Vision of Pediatrics 2020 and thinking about the profession of pediatrics in respect to the anticipated megatrends as follows:
  - 1. Clinical and societal demographic of the patient population
  - 2. Advances in information technology applied to health care and pediatrics
  - 3. Advances in medical knowledge, diagnostics and treatment
  - 4. Form of the healthcare delivery system
  - 5. Consumer driven nature of society and healthcare
  - 6. Workforce in the profession of pediatrics 7. Impact of Disasters (natural, environmental, man-made)

  - 8. Global Child Health and Pediatrics)
- Discussions focusing around loss to follow and lost to documentation (LTF/D) in the context of a new workgroup that has been convened tasked with exploring the role of the medical home in addressing hearing screening LTF/D issues
- The role of health information technology (HIT) was also examined and will continue to be prioritized
- Updates on the AAP newborn screening quality improvement initiatives were provided
- Issues around screening/rescreening in the pediatric office setting were also discussed and will be examined further

The Task Force will continue to address the above through quarterly conference calls and regular e-mail communication.
