- 352 surveys sent; 106 returned
- Return rate: 30%


Q #22: County Distribution

Low Incidence: Sensory Impairment

Any disability for which a small number of personnel with highly specialized skills and knowledge are needed in order for children with that disability to receive Early Intervention services or a free appropriate public education.

Sensory Impairment refers to any diagnosed loss of hearing, vision or a combination of both visual and hearing impairments simultaneously, called deafblindness.

Hearing/Deafness

Hearing loss ranges from mild or moderate hearing loss in the person who is **hard of hearing**, to profound hearing loss in the person who is **deaf**. The use of the term "deaf" generally identifies the person from an audiological testing or measurement perspective, as above. The use of the big D as in "**Deaf**" identifies those people who consider themselves to be culturally deaf.
