Overview of Deafblindness

- Deafblindness refers to combined vision and hearing loss.
- Any range of combined vision and hearing loss that significantly limits the child's ability to get information from people, objects, and activities around them.
- Losses can cause developmental delays: language/communication, social emotional skills, cognition, adaptive, and motor.

National Deaf-Blind Child Count

- Authorized by the U.S. Department of Education, Office of Special Education Progams (OSEP)
- Each state conducts a count of children and youth who are deaf-blind (birth through age 21).
- State data is compiled and reported in the annual <u>National Child Count of Children and Youth who are</u> <u>Deaf-Blind</u>.
- 87% of children on the deaf-blind child count have one or more disabilities <u>in addition to deaf-blindness</u>



^{**}State deafblind projects are unique to to state differences in regulations and legislation, which means that each state collects their child count data in a way to meet these specific needs. The National Center on Deafblindness' child count reports are general in nature with limitations related to completeness and accuracy.

Low Incidence Population


Children Birth - 21

- Blue circle: All children in the U.S. (~90 mil*)
- Yellow circle: Children in special education (~7.3 million**) 8% of U.S.
- Red circle: Children with deaf-blindness (10,585[^])
 .14% of special education

Tips for ID & Referral

- Children identified as D/hh should be evaluated for a loss in vision
- Evaluations should be repeated regularly
- Early identification requires partnership & collaboration
- Once a child is identified, training in deafblindness can:
 - Help young children learn how to access residual vision and hearing
 - Learn skills to support the child's learning, communication & language development, social emotional development, motor development and increase independence
