Families with Deaf or hard of hearing children face considerable obstacles while trying to secure the best possible future for their child. It is our mission to provide you with unbiased information and the support you need.

About MCDHH

MCDHH was established in 1986 to act as the focal point within the Commonwealth of Mas-

sachusetts for Deaf, late deafened and hard of hearing people needing services that were not available or accessible anywhere else. In the intervening years, MCDHH has become a national model for other

states seeking so set up



similar services. While MCDHH's original focus was to provide services to culturally Deaf individuals, our mission has grown to include all citizens of the Commonwealth who are deaf or have a hearing loss, and their families.

Children's Services

Realizing that parents of children who are born Deaf or with hearing loss faced an especially difficult and emotionally draining challenge, the Department of Case Management and Social Services successfully lobbied the State Legislature for the establishment of three specialized regional positions to provide unique support services to these families and their children.

Children's Specialists help to identify needs and issues, provide information about hearing loss, make referrals to appropriate specialized resources and assist parents in working with other agencies. In addition, Children's Specialists also consult with or educate other service providers about the special needs of children who are deaf or have hearing loss.

Children's Specialists are carefully selected staff with an understanding of children and family issues. All Children's' Specialists are fluent in English and American Sign Language. Their services are free and completely confidential. They include the following:

Parent Education relative to the effects of hearing loss at birth, during childhood and in the teenage years



- Identification of Intervention Strategies for parents and others, including the appropriate usage of hearing aids, assistive listening devices and systems, alerting and signaling devices, medical procedures, early intervention, communication and lanquage development and more.
- Objective Information regarding choices for "first language" development.
- Information and Referral to specialized services such as speech and language

- pathology, audiology, psychoeducational evaluation and testing, and targeted counseling services.
- ➡ Technical Assistance to Early Intervention and other educational programs regarding the communication needs of Deaf and hard of hearing children, including acoustical classroom modifications, closed captioning of educational materials, and Communication Access Realtime Translation (CART).
- Education on the cultural perspectives of Deaf parents of Deaf and/or hearing children
- Advocacy and Support to families and agencies in the development and utilization of service plans such as the Individual Family Service Plan for children in early intervention, the Individual Education Plan for school-age children and the Individual Transition Plan for young adults transitioning from education to adult services.
- Connecting Children and Families to recreational and social activities as well as other families and adult Deaf and hard of hearing role models.
- General case management services

- How will I be able to teach my child the things s/he will need to know?
- What will my child do when s/he grows up?
- Are there other families who share similar concerns?
- Is there someone we can talk to?

The good news is that having a Deaf or hard of hearing child is not the tragedy it was once thought to be, and that the vast majority of these children will grow up to be happy, productive and successful adults.

The key to success is acting quickly once the hearing loss is identified. The earlier a plan is put in place, the better the chances of minimizing social, linguistic and cognitive delays.
